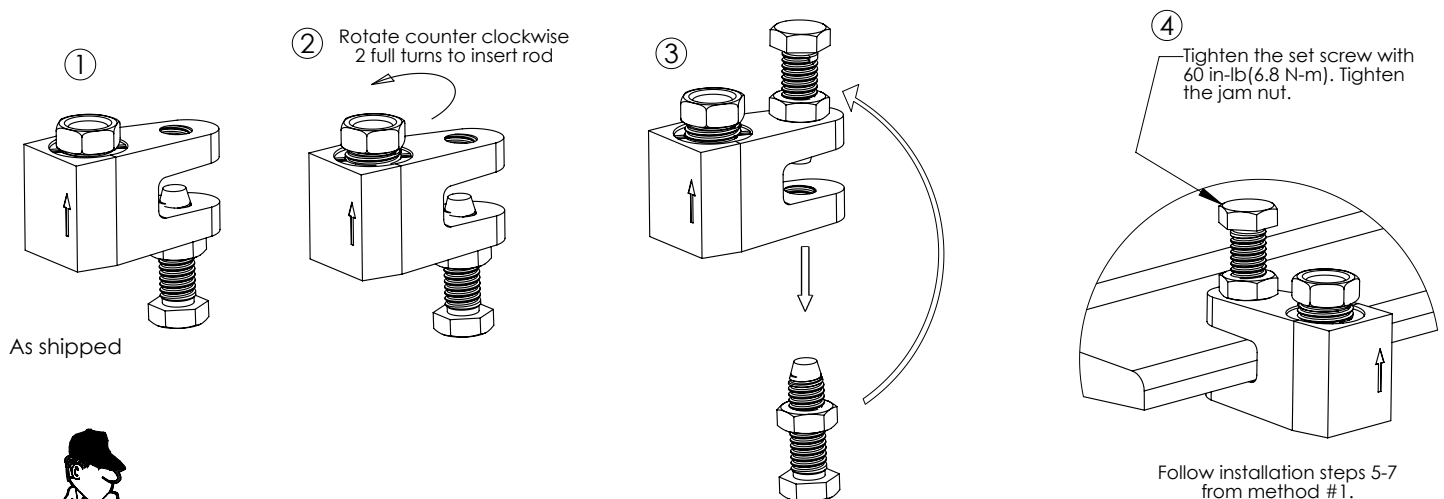


Method #1
